The logo and tagline is a combination of fonts as well as added strokes to make it unique. Do not try to recreate the logo. You may download a logo from this site.

How can I download a PDF file?

Click on the link and save the document within Adobe Acrobat Reader.

What is a ZIP file?

A ZIP file is a single compressed file that may contain one or more files of various file formats. Files are compressed to decrease download time and eliminate the need to download multiple files.

How do I open a ZIP file?

To decompress (unZIP) a ZIP file, you need a ZIP utility. Recommended utilities are PKZip or WinZip (for Windows) and Stufflt (for Macintosh). If you have one of these utilities already installed on your computer, you can simply open the ZIP file. The ZIP utility will decompress the ZIP file and allow you to extract the contents.

How do I get a ZIP utility program?

If you do not have a ZIP utility installed on your computer, you can download a ZIP utility from the internet.

How can I open the logo I downloaded on my Macintosh?

To open the logo, you must have either Adobe Illustrator or Adobe Photoshop on your Macintosh. Launch either application first, then open the logo using that application.
