The referral program allows us to refer you to a third party consultant to assist you with your mortgage needs.

How are we paid for our services?

Our third party agreement will compensate the firm for every successful mortgage referral. A one-time fee of \$500 to \$1,000 will be paid to Edward Jones when you fund a mortgage through the referral program. Each year following the activation of the account, the firm will receive a monthly fee of 0.08333% on the outstanding account balance. From time to time our mortgage provider may provide marketing allowances to promote the service.

How is your financial advisor compensated?

Your financial advisor receives a portion of the one-time fee and a portion of the annual fee, paid on a monthly basis. Our revenue affects Edward Jones' overall profitability and thus may affect any branch bonus your financial advisor receives.
