


Separately managed accounts (SMAs) available at Edward Jones

Separately managed accounts (SMAs) are managed by a professional money manager that may include stocks, bonds, cash and other individual investments. You directly own the investments in an SMA, and a professional money manager manages them separately from the rest of your account. Our Investment Policy Committee provides asset allocation guidance that can help you create a diversified investment portfolio that includes SMAs.
